#### 2.1. Emergency Overview:

This ink does not meet the criteria for dangerous classification according to EU Directive 1999/45/EC. Ink component is a clear liquid that may cause eye irritation. Avoid contact with eyes or clothing. In the case of skin contact, wash with soap and water. Keep out of reach of children.
